The purpose of the Round Table meeting is to involve scientists and practitioners in the discussion of the problems of the negative impact that the environment suffered as a result of russia's armed aggression, and its restoration taking into account the best world practices, as well as popularising the environmental profession, whose representatives will solve these problems after the victory.

Main areas of the Round Table:

- 1. Ecosystems that have been negatively affected by military actions and their state assessment.
- 2. Negative impact on soils as a result of military actions and their reclamation.
- 3. Consequences of fires and other damage to forest plantations caused by war and the main aspects of reforestation.
- 4. Pollution of underground and surface water, negative impact on reservoirs as a result of military operations.
- 5. Problems of overcoming the negative impact of military actions on the natural environment.
- 6. Problems and prospects of forming the strategy for ecological security of Ukraine.
- 7. Legal responsibility for environmental offences during hostilities.
- 8. Humanitarian aspects and international participation in the reconstruction of Ukraine.

Working languages of the meeting: Ukrainian, English.

Participation in the work of the Round Table is **free**, and the format of the meeting is **face-to-face/remote**.

Representatives of authorities, institutions, organisations, scientists, teachers and practitioners, and persons studying, who have deal with environmental problems and who care about the state of the environment in Ukraine are invited to participate.

Based on the results of the Round Table meeting, a collection of materials will be published.

The round table includes the following **forms of participation**:

Required information:

The Round Table participant must take into account:

- All expenses for travel, accommodation and meals are paid at his own expense or at the expense of the organisation that sent him.
- The report should correspond to the topic of the Round Table, contain the results of scientific research and be designed following the specified requirements.
- During the preparation of report materials and participation in the work of the Round Table, it is necessary to comply with the requirements of academic integrity and ethics.
- The organising committee reserves the right to review materials of reports sent for publication in the collection.
- The organising committee will deny participation to persons who support the aggressor country and the war in Ukraine, and allow violations of academic integrity and ethics.

Requirements for the design of materials for publication in the collection:

The amount of text of the report materials should be 2-3 full pages in A4 format, typed in one of the working languages of the Round Table on a computer in the WORD

text editor for WINDOWS. Typeface – Times New Roman, point – 12, spacing – single, paragraph – 1.0 cm. Margins: 2.0 cm on all sides, without page numbering. Formulas are typed in the Microsoft Equation formula editor. The letter designations included in the formulas must be decoded with an indication of the units of measurement. The numbering of the formulas is sequentially (the number is indicated in round brackets near the right border of the text). References to literary sources should be indicated in the text in square brackets. Abbreviations and conventional designations must comply with current international standards.

Procedure for processing materials:

- **UDC** (bold font, top left);
- across the line NAME OF THE REPORT (in capital letters, bold, in the centre);
- across the line authors' initials and last name, scientific degree, academic title, place of work (italics, centred);
- through a line the text of the materials (formulas and tables are placed in the text and separated from the text by an interval of 1 line);
- across the line a list of the references (the word **REFERENCES** is written in the centre, in capital letters, in bold, drawn up according to the standards of bibliographic description given in DSTU 8302:2015).
